HALECREST PARK, INC. MEMBERSHIP AGREEMENT

(A Membership Owned Park)

DEFINITIONS

For clarification, the word "Member" is intended to include, as appropriate, all persons named in the Membership Application as being part of the immediate family, living in the member (s) household at the address stated on the Membership Application. The word "Park" shall refer to Halecrest Park, Inc.

The undersigned member(s) and Halecrest Park, Inc. (Park) hereby agree to the following:

MEMBERSHIP TERMS

The undersigned member shall be obligated to maintain membership and pay all application fees and dues for the initial period of twelve (12) months (from the date membership begins, to the date that member completes twelve (12) consecutive months). Thereafter, membership shall be maintained and paid for on a monthly or annual basis.

FEES AND DUES

Monthly dues are \$60.00. A member shall be entitled to a 10% discount when an advance annual payment of dues is paid at any time during the term of membership. Annual dues shall be calculated as: $\$60.00 \times 12 \text{ months} = \$720.00 \times 10\% = \$72.00$ discount for an annual payment of \$648.00. The Park reserves the right to change at any time, upon 30 days written notice to members, the amount of monthly dues members are to pay. Any increase of dues shall not affect those memberships that have paid their annual dues in advance, until their annual payment has expired.

MEMBERSHIP DUES AND OTHER CHARGES

Monthly membership dues are to be paid on the first (1st) day of each month and shall be considered late if received after the fourteenth (14th) day of the month. A **\$15.00** service fee shall be added each month the payment is late. Any members check returned unpaid by the bank, shall incur a **\$15.00** returned check charge, **plus** bank charges incurred by the Park.

UNPAID DUES

Member understands that non-payment of monthly membership dues and/or Park charges will result in the Park having to pursue **COLLECTION ACTION**.

PARK KEYS AND KEY DEPOSITS

A member who has been issued keys is obligated to pay monthly membership dues and maintain membership in Good Standing. Two (2) keys are allowed per membership. Key deposits will be refunded upon resignation and when park key(s) are returned. Member(s) will be charged **\$60.00** for each lost key.

MEMBERSHIP RESIGNATION

Member(s) may resign upon completion of the first twelve (12) consecutive months of membership by completing a written resignation form, returning park keys(s), and paying all outstanding charges or dues.

MEMBERSHIP TERMINATION

The Board of Directors may terminate membership by a majority vote and a written statement notifying the member(s) of such action.

LIABILITY

The Park disclaims all liability for personal injuries to members or guests and for damage of their personal property however incurred while on Park premises. Member agrees to indemnify the Park and hold the Park harmless from any liability arising out of the use of the Park by a member or their guests.
